BOARD MEETING: The NAEA WC Board meetings provide a venue for a panel of WC mentors and board members to lead sessions/discussions on a range of topics related to the conference themes and issues of equity related to our mission. This session is followed by a time for participants to address questions to the mentor panel. WC Board Meetings at the NAEA 2013 conference included: Advancing 21st Century Feminist Visions and Agendas and Building 21st Century

Communities of Practice.

Board meetings at the NAEA March 2014 conference will include: **Using Web 2.0 for Advocacy**, **Teaching**, **Collaboration and Research** (Sheri Klein, Jennifer Motter, Christine Woywod, Olga Ivashkevich) and **Fusing Passion With Praxis: Insights and Strategies From the Women's Caucus** (Elizabeth Delacruz, Karen Keifer-Boyd, Marissa McClure Sweeny, Joanna Rees) that will be devoted to putting ideals into practice through technology-infused, feminist-inspired teaching, research, collaboration, and advocacy.

CONFERENCE EXHIBIT: Initiated in 2010 as an annual exhibition catalogue of juried members artwork, the 2013 WC exhibition color print catalogue was designed by Mildred Ochoa (Univ. of Arizona). The exhibition catalogue is a benefit of membership, and distributed at NAEA to members and mailed to those not in attendance. Additionally copies can be purchased. The juror for 2013 was **Linnea Glatt** and there were **15 WC members' entries accepted** in the exhibition.

The juror for the 2014 exhibit is **Dianna Cohen.** There were 16 artist submissions with over 40 works. **The juror accepted 14 works by 10 WC artist/members.** The catalog designer is Tom McCarthy (Univ. of Arizona).

Community: NAEA will build a more cohesive professional community among art educators, museum art educators, and artists through enhanced communication strategies.

Outreach coordinators, **Christine Woywod and Olga Ivashkevich** continue to upload postcard installations.

This past year's post card theme was **Half the Sky**. Initiated by Sheri Klein, the intent was to address issues related to violence and it related to the national movement. Responses were on 4 x 6 in. postcards. There were a total of 15 submissions and they are posted on the WC Voices Blog and the WC Facebook page: http://naeawcvoices.wordpress.com/half-the-sky/

We also have a listserv for announcements and we use bulk email to all members for particular messages.

Advocacy: Focus on communicating the importance of student learning and lifelong learning in the visual arts to art educators, policy makers, parents, and the community.

Through research, publication, workshops, teaching, and awards the Women's Caucus focuses on the importance of learning about issues of gender in the visual arts. Beyond the WC sessions, meetings, and events that reside within the formal protocol of the NAEA, the **Lobby Session** serves as an informal forum for personal as political discussion and/action.

The 2014 Lobby Session continues this annual discussion begun in 2008. Each year Lobby session attendance has increased, with more than 75 participating during recent sessions. Lobby session guiding questions/prompts include:

2014: Speak Truth to Power

2013: What are my personal responsibilities and our collective responsibilities to end violence?

2012: "What do you believe is critical to lobby for in 2012"

2011: "A Time When ... "

2010: "What is the Image of a Feminist in the Field of Art Education Today?"

2009: "Enacting Change: What We Can Learn From Each Other?"

2008 Collaborative JAE publication: "Vote 2008: What Should an Art Educator Do?"

The **2013 Lobby Session** focused on violence and that culminated in an article by WC members: Lisa Kay and Alice Arnold. The article (in press) is titled "Order from chaos: An arts-based approach to counteract trauma and violence" and will be published in the *Journal of Art Education*.

The **2014 Lobby Session** will focus on the theme of "Speak Truth to Power" using the academic gown and/or the artist apron as visual symbols and metaphors to guide responses from participants.

Research and Knowledge: Focus on expanding access to information on current and emerging policy issues that affect art education.

Women's Caucus members address policy through our research and some address policy per se. Also, through writing and presentations, we provide access to contemporary practices through which learners can address gender identity and issues arising from gender. We have four areas of resources for research that we provide and continue to develop, which are accessible on our website at http://ngeawc.net/research.html

Research Reports on Gender Issues in Art Education: This area includes research reports or summaries under 1000 words, which state the research problem or question, articulate the methodology, and present findings in a form that can be influential to policy makers and/or put into practice by art educators.

Research into Praxis: This research is dedicated to feminist theory applicable in K-12 art education.

Resources: These are resources helpful in conducting research relevant to the WC mission.

<u>Publications:</u> These are journals, links, videos, organizations, and exhibitions relevant to the WC mission.
